

Advertisement for the post of Chairman, Bihar State Pollution Control Board

Applications are invited from eligible Indian nationals for the post of Chairman of the Bihar State Pollution Control Board, headquartered at Patna, in accordance with the State Pollution Control Board (Manner of Nomination and other Terms and conditions of service of Chairman) Rules, 2024.

Bihar State Pollution Control Board is a body corporate constituted by the State of Bihar under the Water (Prevention and Control of Pollution) Act, 1974 and also empowered under the Air (Prevention and Control of Pollution) Act, 1981 for prevention and control of water and air pollution in the state. Bihar State Pollution Control Board is also a prescribed authority under the different waste management rules notified under the Environment (Protection) Act, 1986.

Job Description & Responsibility:

The Chairman being the head of the Bihar State Pollution Control Board is responsible for efficient functioning of the Board for achieving its objectives as defined under the Water (Prevention and Control of Pollution) Act, 1974; the Air (Prevention and Control of Pollution) Act, 1981; the Environment (Protection) Act, 1986 and the rules made thereunder.

Eligibility:

- (i) **Age limit :** The candidate should be less than 63 years as on 01.06.2026
- (ii) **Qualification :** Person having special knowledge or practical experience in respect of matters related to environmental protection or a person having knowledge and experience in administrating institutions dealing with the matters aforesaid.


Duration of Appointment : The Chairman of the Bihar State Pollution Control Board shall hold office for a term not exceeding 3 years from the date on which he/she enters upon office or until he/she attains the age of sixty five years, whichever is earlier.

Pay and allowances : The Chairman shall be entitled to receive pay and other allowances as admissible to a Central Government officer holding a Group 'A' post carrying Pay of Level-17 in the pay matrix of the Seventh Central Pay Commission. In case of a person who retired from service under the Central Government or the State Government and he/she receives pension (if applicable), his/her pay as Chairman shall be reduced by gross amount of pension received by him.

Selection Procedure : Suitable candidate shall be selected by the Selection Committee as constituted under the provisions of the State Pollution Control Board (Manner of Nomination and other Terms and conditions of service of Chairman) Rules, 2024.

Submission of the Applications : Interested candidates may submit online application complete in all respects along with copies of certificates/testimonials in the prescribed format available at the website of the Department of Environment, Forest and Climate Change, Govt. of Bihar at <https://state.bihar.gov.in/forest/CitizenHome.html> latest by **06:00 PM on 05.06.2026** Submission of form by any other mode will not be acceptable. No communication in this regard will be entertained.

Other Terms and conditions : Other Terms and conditions regarding Nomination of the Chairman as mentioned in the State Pollution Control Board (Manner of Nomination and other Terms and conditions of service of Chairman) Rules, 2024 shall also be applicable.
